Both are registered charities numbers: 1040554 and 1159162 respectively. The CIO is the corporate trustee of CWA and the CIO is governed by a Board of Trustees—see page 5 for details.

CWA is a registered housing provider, regulated by the Homes and Communities Agency.

Our aim is to provide good quality, affordable social housing for older people who have a housing need and who have a connection with the City of Wells.

# Foreword

## By Simon Bruce, Chairman of Trustees

Following the retirement of the Very Reverend John Clarke, Dean of Wells, in December 2015 I was delighted to be elected as Chairman of the Trustees, and to be supported in this role by my Vice Chairman Nick Wilson.

It has been a busy year for CWA as we have continued with the planned programme of improvements to our properties to meet our objective of ensuring they are as warm, safe and comfortable for our residents as possible. Of particular note in this direction was the granting of our planning application to double glaze the windows at the rear of Llewellyn's.

We recognise the challenging issue of rising energy costs for our residents and this year we have continued with our programme of installing secondary double glazing together with storage heater and boiler replacements. We have also had a number of void properties this year which has provided us with the opportunity to continue with our programme of upgrading and improving the properties. However, all our properties are now occupied and we are delighted to report that we have a waiting list of potential residents who meet our criteria for occupation.

Although we are continuing with our major capital programme, as Trustees, we are aware of the ongoing substantial costs of maintaining listed buildings. We are therefore planning to enhance neighbourhood awareness of the Almshouses and the work we do, by undertaking some dedicated marketing activities and events which are focused on generating interest among those who could support us financially.

Also, this year, our Chief Executive Officer, Kate Knight, decided to retire. I would like to record my thanks for her considerable work over the past three years enabling us to improve our building stock, the organisational structure, and our ability to meet our obligations as a Charity.

We undertook a recruitment process to replace Kate in the summer of 2016, and I am delighted to say that Althea Howarth, a housing and development professional, joined us on 1 September. I am certain that under Althea's management we shall continue to build on the excellent foundations that Kate laid.

Finally, I would also like to thank my fellow trustees, staff, residents and volunteers for the support and encouragement they have offered me during my first year as Chairman.

### Our ongoing Capital and Refurbishment Programmes

Major works during the year have included: Phase 1 of the secondary double glazing programme; a continuation of the boiler and storage heater replacements and; refurbishment of our properties as they become vacant. Further work during this financial year will include Phase 2 of the secondary double glazing programme and the installation of an up to date CCTV system on the Bubwith site.

### Resident Power

As some of you will be aware our original planning application for double glazed windows at the rear of the Llewellyn's properties was refused and on 20 July our residents and staff attended the Council meeting where a new application for the works was being considered. A minibus was hired and residents travelled to the meeting with their banner. The application received unanimous approval and the work has now been tendered. The work to install the replacement windows is scheduled to commence in early 2017.



### The Queen's 90th Birthday

The residents of Llewellyn's, headed by Margaret Milnes, organised a sumptuous feast accompanied by sparkling wine. The event was hosted on the patio at Llewellyn's and was attended by residents, staff and their families. It was a beautiful sunny afternoon and the event was thoroughly enjoyed by all who came.

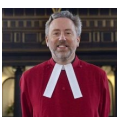

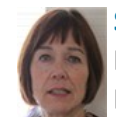

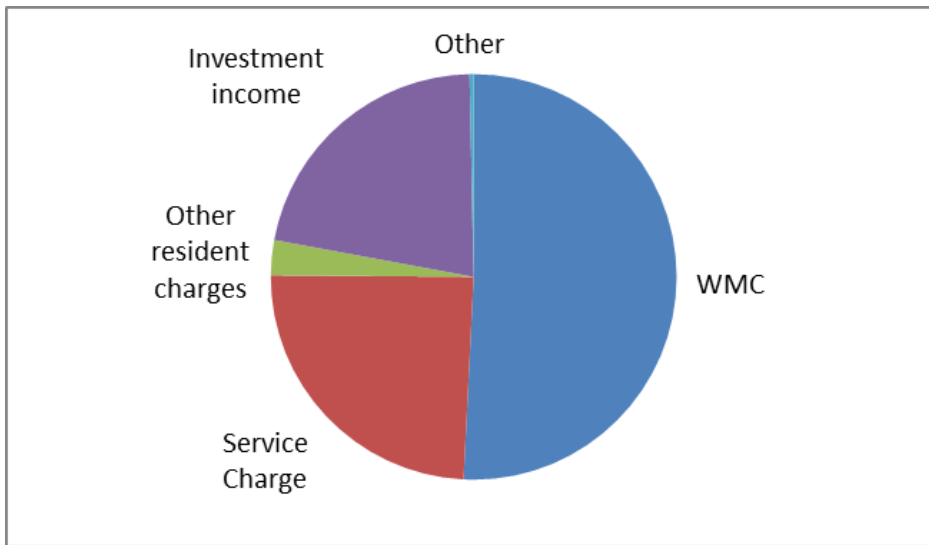

# THE FINANCES FOR THE FINANCIAL YEAR ENDED 31 MARCH 2016

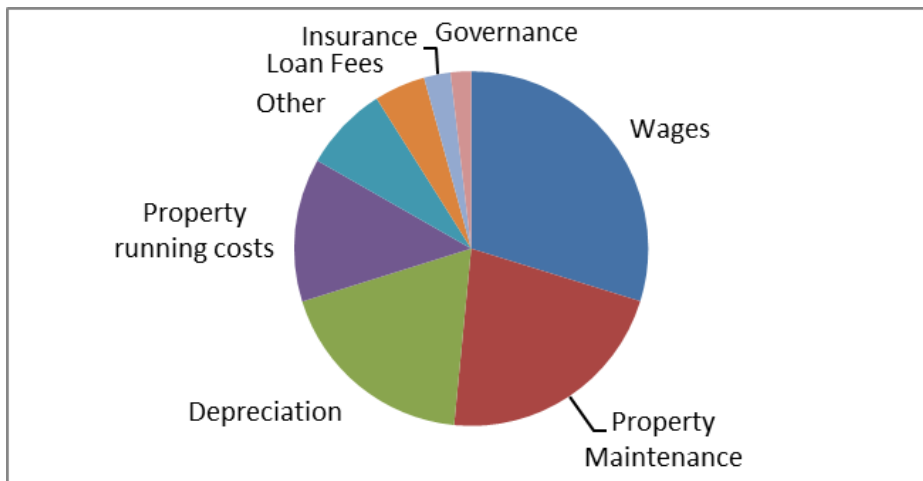
## INCOME

Our total income for the year was **£221,541**. The graph below shows our main sources of income:



## EXPENDITURE

Our total expenditure for the year was **£179,841**. As you might expect wages and property associated costs are our highest costs. The graph below shows our main sources of expenditure:



## OVERALL OUTCOME

Our income before investment gains and losses was a surplus of **£41,700** in the financial year ended 31<sup>ST</sup> March 2016. All of the surpluses made are retained and invested for the benefit of our residents.

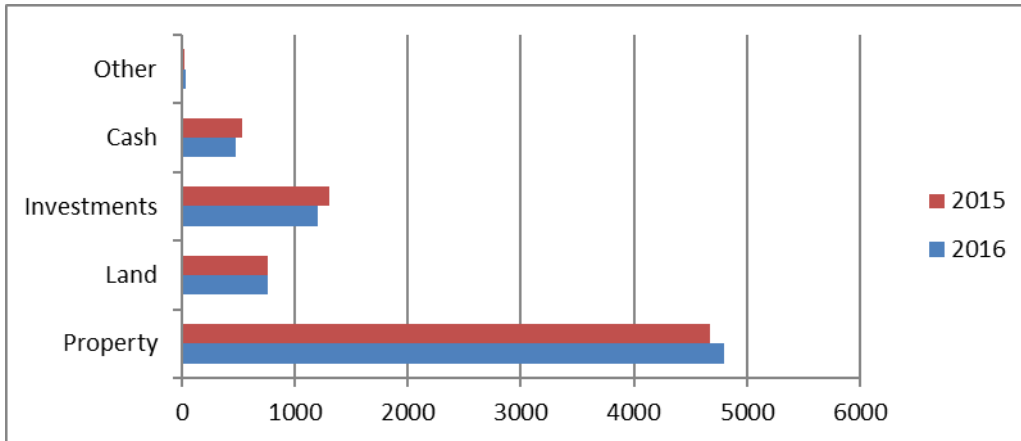

## ASSETS

## LIABILITIES

At 31 March 2016, 34% of our liabilities relate to a loan of **£194,683** arranged with the Charity Bank in the previous year in order to help with our programme of improvement. This is fully repayable by 2040. A further 64% of our liabilities relate to social housing grants which were received several years ago to help fund property improvements.

## OVERALL POSITION

Our total assets as at the 31<sup>st</sup> March 2016 are **£6,697,522**.

## CAPITAL PROGRAMME

We have agreed a programme of major improvements to our properties to ensure that residents have suitable accommodation and to keep our properties safe for the future. A total of **£143,000** was spent on our property in the year, as follows:

External work to Llewellyn's terraces	£74,000
Major property refurbishment x 4	£57,000
Secondary glazing	£7,000
Replacement heaters	£5,000

We also spent the following:

Property redecorations	£10,000
New boilers x 2	£6,000
Stairlift	£5,000
Repainting walls	£5,000

**T**his year we have also said farewell to **Wilf Beer** who has tended the gardens at Bubwith for over 25 years and handled the arrangements for the Christmas Carol service in the chapel. Wilf's dedication and hard work resulted in the Bubwith garden winning an outstanding Level 5 award from the RHS. Maintaining the high standard achieved



within the Bubwith and the other gardens will be a challenge for CWA and we wish to thank those helpers from Heads Up and also Christine, Jean, Judy, Mo, Peter and all the other residents for their continuing efforts. We were also delighted recently to welcome Annette and Carol to our team. ## About The City of Wells Almshouses

There are five almshouse buildings in the City of Wells Almshouses' complex, providing 32 individual flats and cottages.

The earliest was founded in the fifteenth century through a legacy provided from the estate of the former Bishop of Bath and Wells and Treasurer to King Henry IV, Nicholas Bubwith. Bubwith's Almshouse is located next to St Cuthbert's Churchyard and includes a chapel and guildroom.

In the early sixteenth century an alderman of the city, Henry Llewellyn, left a legacy to build a further series of almshouses, on a separate site in Priest Row, to the north of St Cuthbert's Church.

Yet more accommodation was provided through legacies from Bishop Still and Bishop Willes and in 1637 the Bubwith site was expanded again through a legacy from Walter Brick, a Burgess of the City.

Originally separate charities, they are all now

part of CWA. As well as the architecture, the almshouses also have beautiful gardens, which are tended by the residents and a small, but enthusiastic band of volunteers.
